Energy Group participates in Intersolar Europe 2025 to present storage solutions dedicated to the European market

The event, an international reference for solar and energy storage, will be held from 7 to 9 May 2025 in Munich.

Sant'Angelo di Piove di Sacco (Padua), April 23, 2025 – Energy S.p.A., an Italian company listed on the Euronext Growth Milan market, (ISIN Code IT0005500712, Ticker ENY), parent company of the Energy Group, a full system technology manufacturer, BESS (Battery Energy Storage System) leader and cloud and engineering services provider, will be present at Intersolar Europe 2025, scheduled from 7 to 9 May in Munich, at the EES - Electrical Energy Storage exhibition space (Hall B2, Stand 240). The event represents the most important European meeting point for solar energy and storage professionals, offering visibility to innovative technologies and strategies for the energy transition.

During the event, Energy will present its BESS (Battery Energy Storage System) solutions developed specifically for the European market, in particular the zeroCO₂ XL Shell 100/220 systems, in the new configuration dedicated to the EMEA area, and XL Box, the containerized solution for grid-scale applications. Both systems are designed to ensure high efficiency, reliability and sustainability, responding to the specific needs of European companies and utilities that aim for energy autonomy and grid stability.

The zeroCO₂ XL Shell 100/220 model is an evolution from its predecessor, with an increased capacity that leaves the footprint unchanged. It is a compact all-in-one system, ideal for outdoor installations in the Commercial & Industrial segment, equipped with proprietary electronic components and software for the intelligent management of stored energy. XL Box, on the other hand, offers a modular containerized configuration for large-scale plants, enabling flexible solutions for the management of complex energy flows and integration with renewable sources.

The integration that the Energy Group can guarantee thanks to its expertise between internal production, software development and plant design allows it to offer turnkey solutions with high technological content, with particular attention to cybersecurity and personalized technical support.

The **Energy Group** is a full system technology manufacturer and BESS (Battery Energy Storage System) leader for residential use and large-scale applications, and a provider of cloud and engineering services on the Italian and European markets. The Group emerges from Energy S.p.A., founded in 2013 by Davide Tinazzi, Andrea Taffurelli and Massimiliano Ghirlanda, listed since August 1, 2022 on the Euronext Growth Milan market of the Italian Stock Exchange (ISIN Code IT0005500712, Ticker ENY), which was joined by EnergyInCloud S.r.I. and Enermore S.r.I. in 2023 and 2024 respectively. Energy has to date sold and installed more than 65,000 systems across the country, with a focus on the residential, commercial, industrial, utilities and electric mobility markets.
